Club Improvement Project

The Planning Committee of Bay View Yacht Club has contracted to replace the flat roofs on the clubhouse (including main deck and smaller side roof areas) and replace the 5 air conditioning units on the club roof and the A/C unit for the Commodore Room/galley. Work will begin very quickly and there should be no interruptions to the club or its functions.

Proposed change to BVYC Constitution

Reason for change: To be bring our membership levels into compliance with our liquor license and provide the ability to serve fellow AYC and ILYA members at the bar.

The BVYC constitution currently reads:

Article VII

Class of Membership

Section 1

There shall be five classes of membership: Honorary Life, Active, Spouse, Social and Provisional. The membership card issued to each shall designate the type of membership held. Honorary Life, Active, Social and Provisional classes of membership shall include the Spouse membership; however the Spouse privileges shall be limited to the purchase of bar and food items only.

Proposed change:

Article VII

Class of Membership

Section 1

There shall be six classes of membership: Honorary Life, Active, Spouse, Social, Provisional and Affiliated. The membership card issued to all but Affiliated shall designate the type of membership held. Honorary Life, Active, Social, Provisional, and Affiliated classes of membership shall include the Spouse membership; however the Spouse privileges shall be limited to the purchase of bar and food items only.

Constitution currently reads:

D. Provisional Membership

A candidate having filed a B.V.Y.C. membership application with the proper fee and is on the waiting list and has been interviewed and approved by the membership committee ...

Section 2 - Courtesy Cards

Proposed change: Inclusion of item E

D. Provisional Membership

A candidate having filed a B.V.Y.C. membership application with the proper fee and is on the waiting list and has been interviewed and approved by the membership committee ...

E. Affiliated Membership

A member in good standing of a club that is either a member of the Associated Yacht Clubs (AYC) or the Inter Lake Yacht Association (ILYA) shall, without further action by B.V.Y.C., be an Affiliated member. Such membership shall be confirmed by presentation of a current and valid membership card issued by either an AYC or ILYA club. Such person shall not be deemed to be an Active member, but shall have the rights of an Active member with respect to alcohol related services and participation at social events. Anything contained herein notwithstanding, an Affiliated member may be suspended or expelled for just cause.

BVYC Winter Storage (2014 – 2015)

Scheduled winter storage haul out begins in October at 8:30am on weekends. The charge for this year is \$6.50 per foot, LOA.

Sunday Oct. 5th will be the first day. (Saturday Oct. 4th is the color cruise).

Members should be prepared to help all other members on the day that they pull their boat. Anyone wanting to work winter storage should report at 8:30am at the haul out shed.

Note: An application for winter storage must be filled out and signed before your boat will be pulled. The applications are at the bar.

JUST A REMINDER **SHRINK WRAP RULES**

Shrink wrap rules: **Before** the shrinking process begins, it is the **boat owners** responsibility to see all the following conditions exist within an area of 10 feet surrounding the boat to be shrink wrapped. **OWNERS MUST MAKE SURE CONTRACTORS ARE COMPLYING WITH THESE RULES.**

- A) All fuel tank vents are to be temporarily sealed with tape. (Note the 10 foot rule above).
- B) A fully charged fire extinguisher, type ABC minimum UL rating 4A60BC will be in close proximity of the vessel being wrapped.
- C) Minimum of one helper/observer present.
- D) A ladder, scaffold, or similar platform to provide a safe, sturdy means of reaching all areas of the vessel that requires the shrinking process.
- E) BVYC equipment is not to be used to comply with these conditions.
- F) Tape must be removed from the adjacent boat fuel vents when the shrink wrapping is completed.
- G) Shrink wrapping is to be done during the daylight hours only.

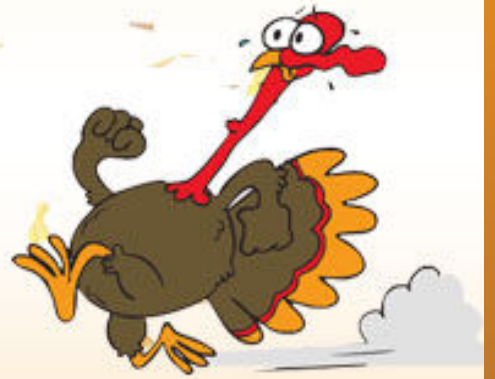

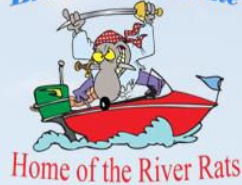
